## Fhyn FD: know where shut-off valve is

Fairhaven Fire Dept. Press Release

Over the weekend the Fairhaven fire department has responded to approximaely 12 calls for broken water pipes in residential properties within town due to the freezing temperatures.

We also had broken water pipes in town business such as Serenity Salon in the Lifestyles Plaza, Dollar Tree Store, Seaport Inn and the Fairhaven Recreation Center. There were also frozen sprinkler pipes at the S.E. Mass Credit Union.

The Fire Department typically sees an increase in calls when the temperatures begin to warm and the frozen water pipes thaw after they have split. Residents are reminded to know where their water shut-off valves are in their homes to help minimize damage should a water pipe break.

Usually stopping the water flow is as simple as the turn of a valve.

# Shovel out mailboxes, sidewalks

Letter carriers need to be able to get to your mailbox. Please shovel so that the truck can reach your mailbox if you have one outside your house. If you have a group of mailboxes, such as those on West Island, please be neighborly and shovel the snow.

Letter carriers are not required to deliver mail if there is snow in the way. It is the responsibility of the home owner to shovel.

Also, property owners are responsible for shoveling a pathway in front of their homes and businesses.

# Planning Board supports two, rejects one street acceptance

The Fairhaven Planning Board voted to support two requests for street acceptances, and rejected one at its meeting on Tuesday, 2/9.

Town Planner and Economic Development Director Bill Roth recommended not accepting the south side of Welcome Street, but the board voted 4–2 to support it anyway.

All street acceptances must be passed at Town Meeting. The article will appear on the warrant of the TM in May.

Mr. Roth told the board that the south side of Welcome Street was not paved. He said the town should not accept ways that will require a lot of construction and cause a "burden" for the department of public works.

The DPW will have to handle upgrading the road, which is now a private way.

The Selectboard had received the article request by petition from residents and forwarded the article to the PB for a recommendation. The Selectboard had also used its own engineering funds to create a plan for the road.

PB Chairperson Wayne Hayward noted that the town has, in the past, accepted and upgraded at least one road that was much longer than the section of Welcome Street "without anybody living on it."

The Welcome Street portion is less than 1,000 feet long and has a handful of homes on it.

After some discussion about the addresses of those who signed the petition and whether or not all the homeowners on the street had been contacted, Mr. Hayward said they should know by now.

"If they are not in agreement and say that at Town Meeting....it ain't gonna happen," said Mr. Hayward.

In another matter, the Board of Public Works submitted a request for Rockland Street, between Sconticut Neck Road and Point Street, to be accepted. Mr. Roth recommended accepting Rockland Street and authorizing associated costs, saying the street was paved and that the BPW had recommended it.

"I don't understand how this got missed," said Mr. Hayward, noting that all the streets around it had been accepted.

He said the town did a "blanket acceptance and weeded out the ones that had encroachments."

But Rockland Street has no encroachments.

"When I drove down it, I was shocked it wasn't accepted," said Mr. Roth.

The board voted unanimously to recommend acceptance at Town Meeting.

The board did reject one request for support of a street acceptance and associated costs.

Treasure Bay Lane between Reservation Road and Billy's Way is a gravel road.

In his memo to the board, Mr. Roth said the road is a "combination of gravel driveway to a house and the remainder is lawn area towards Billy's Way."

The road does not meet town standards, he said, so it should not be accepted.

"It makes no sense," said Mr. Roth, noting he looked at it on Google Earth and the road does not go anywhere.

"It's just a gravel driveway to a

house," he said. "It's a paper street, literally."

The board rejected the request unanimously.

All three requests will be on the TM warrant in May.

The board also received revised plans from Clean Energy Collective for a solar farm at 197 New Boston Road.

The two megawatt facility requires a special permit, and will be built on approximately 12.5 acres near the New Boston Road end of the Costa Farm. The farm itself is approximately 53.86 acres.

The hearing had been continued from 1/12 for some changes to be made, mostly to drainage issues.

The board approved the plan, after tweaking the 17 conditions of the special permit, ending up with 16 conditions.

Conditions include that lighting will not emit glare beyond the property line, and that pile driving during construction will be limited to the hours of 8 a.m. to 4 p.m., Monday through Friday.

The board approved the special permit unaninmously, 6–0. Board member Rene Fleurent was absent, and Kaisa Cripps's seat is vacant.

The Costa Farm is a 61A property, meaning it gets tax breaks for being open space and the town has the right of first refusal in case of a sale or a change in use. The PB voted not to recommend exercising the right to buy the land. The Selectboard also has to vote on 61A properties.

The meeting will be held in the banquet room at **Fairhaven Town Hall**, **40 Center St.**, **Fairhaven**.

The proposed project would be entirely subtidal upon completion and would involve placement of aged shell and hatchery-produced oysters on the sea floor of Little Bay with the goal of establishing a permanent oyster population. Project goals include improving water quality and habitat, and enhancing harvestable shellfish populations. Public input is welcome.

## Recipe of the Week Seafood Lasagna

1 lb. cream cheese 3 scallions, trimmed and chopped 1/4 cup milk

2 teaspoons Creole seasoning2 sweet red peppers, cored,seeded and finely diced

2 10-oz. boxes frozen chopped broccoli, thawed & squeezed dry

3/4 lb. crabmeat, shredded 2 eggs

1/2 tsp salt

1/4 tsp black pepper

1 1-lb. jar alfredo pasta sauce 12 no-boil lasagna noodles

1/4 cup grated Parmesan cheese

Heat oven to 350°. Coat 13 x 9 x 2-inch baking dish with nonstick spray. Stir cream cheese, scallions, milk and seasoning in bowl until smooth. Stir in peppers, reserving 1/2 cup, and broccoli, reserving 1 cup. Add crabmeat, 1 egg, salt and pepper. Whisk remaining egg into alfredo sauce.

Spread 1/3 cup alfredo sauce into baking dish. Top with 3 noodles, one-third of the crab mixture and one-fourth of alfredo sauce. Repeat layering twice. Top with 3 noodles; sprinkle with reserved red peppers and broccoli. Pour on remaining alfredo sauce. Sprinkle with Parmesan.

Bake, covered, at 350° for 30 minutes. Uncover; bake an additional 20 to 25 minutes, until browned and bubbly. Let stand 10 minutes.

## Truck flips over on Goulart into water

A black Ford F250 pickup truck flipped over onto its roof and landed in about seven feet of water on Goulart Memorial Drive, trapping the driver inside at about 3 p.m. on Wednesday, 2/17.

Long time West Island resident David Cardin, 61, was taken to St. Luke's Hospital where he remained in critical condition as of press time on Wednesday.

Police and fire would not release the driver's name, but people on the scene and friends confirmed it was Mr. Cardin.

The truck went off the road and over the rocks on the north side just before Earl's Marina, landing in Jack's

Cove, where the small, private marina's mooring field is.

Police officers Scott Coelho and Alexander Kisla were first on the scene, jumped into the frigid water and pulled Mr. Cardin from the vehicle, which was about 15 feet from the road. Officer Kevin Chasse swam around to the passenger side to determine if there were any passengers.

Nathan Picard, owner of Picard Tile,

also jumped into the water and

helped the officers bring Mr. Cardin back to the road.

Fairhaven Fire Department Deputy Chief Todd Correia had entered the water at that location and provided assistance lifting the victim back to dry land. The victim was then lifted up to the road surface where paramedics from the Fairhaven Fire Depart-






ment began administering lifesaving treatment.

As the first round of officers were exiting the 39-degree water, Detectives Jerald Bettencourt and Scott Gordon jumped in and made

## **Boat aground on West Island abandoned**

A boat that appears to have been purposely abandoned ran aground on West Island last week.

Fairhaven Harbormaster Timothy Cox said that he believed he had tracked down the owner and spoke to him once, but now he is having difficulty getting in touch with the Dartmouth man.

To complicate matters, the anchor Mr. Cox used to secure the boat has been stolen, and the boat has been vandalized.

The "Second Wind," previously homeported in Riverside, RI, was tossed up on the shore during the big winds, storms and extra-high tides last week. It was first noticed on Wednesday, 2/10.

Mr. Cox did some detective work and tracked down the most recent history of the boat. It had been donated to a charity that auctioned it off. The person who bought it decided it needed too much work, so he abandoned it on a mooring in Falmouth, owned by the former owners of the boat, the RI couple that gave it to the charity.

The charity managed to get a new title for the boat and sold it to a different person, a man who lives in Dartmouth.

"Last Saturday the boat left Falmouth around noon time and as far as it got was around West Island," said Mr. Cox, declining to speculate on how it only got part way to

Dartmouth.

There are few moorings between Falmouth and Dartmouth in a position for boat to end up on West Island.

He said the new owner told him that he was motorsailing and had engine trouble, but it was unclear how the boat ended up adrift.

"I talked to him once," said Mr. Cox. "He said it was not really his, that he was moving it for someone else.'

Although the boat is in Fairis actually state

land, owned by the Department of Conservation and Recreation.

Mr. Cox contacted the Environmental Police and DCR. Both agencies are assisting in removing the boat.

"EPOs are the one to resolve this and to get this person to move the boat," said Carl Pastore of DCR. "They're the enforcement authority to work with the Harbormaster to try

> to get the owner to remove it.'

> He said Mr. Cox had done a great job of tracking down the owner so that someone can be held accountable for the costs of removing the boat. He said a ranger did go to look at the boat and get a status, but it is the EPOs who will handle getting it removed, not DCR.

"You can't just abandon a boat," said Mr. Cox. "It's against the law to

The boat is a 25-foot O'Day, "a pretty decent boat," said Mr. Cox.

He said it will be quite the project to move it. There is no way to get a trailer to it by land, and it will require a tugboat by water. Then it will have to be hauled out of the water to be stored.

"I don't have the money to pull this off," said Mr. Cox, adding he already lost a \$200 anchor. "I don't want to leave it there."

If it stays, he said, it will break up eventually and cause pollution to East Cove, arguably, the closest thing to pristine we have in this area.

"It's [going to] be a mess," said Mr. Cox. "It's [going to] be a mess back there and we don't need that."



# Cold weather safety tips for propane users

Press release from Gas Association of New England

Homes and business that use propane to generate heat or run appliances should make sure to take the following steps to keep everyone safe and warm:

- Check your chimneys, flue pipes, vent connectors, and propane tank for damage, blockage, or debris caused by snow or ice. Use a broom rather than a shovel, and clear these areas frequently. This will help reduce the possibility of carbon monoxide poisoning due to blocked or damaged chimneys, flues, and vents.
- Use extreme caution when operating portable generators. Never use a portable generator (gasoline, diesel, or propane) indoors or in enclosed areas. This can result in carbon monoxide poisoning or death.
- Never use a stove for space heating and never use outdoor propane appliances indoors or in enclosed areas. Proper ventilation is

necessary for their safe operation; and carbon monoxide fumes emitted can be lethal. Only use appliances indoors that are designed and approved for indoor use.

## If you smell gas

If you smell gas inside or outside of your home or business, follow these instructions:

- No flames or sparks! Immediately put out all smoking materials and other open flames. Do not operate or turn on or off lights, appliances, telephones or cell phones.
- Leave the area immediately. Get everyone out of the building or area where you suspect gas is leaking.
- Shut off the gas. Turn off the main gas supply valve on your propane tank, if it is safe to do so. To close the valve, turn it to the right (clockwise).
- Report the leak. From a neighbor's home or other building away from the gas leak, call your propane

retailer right away. If you can't reach your propane retailer, call 911 or your local fire department.

- Do not return to the building or area until your propane retailer, emergency responder, or qualified service technician determines that it is safe to do so.
- **Get your system checked.** Before you attempt to use any of your propane appliances, your propane retailer or a qualified service technician must check your entire system to ensure that it is leak-free.



# Candidate field set for April 4 election; three contested races

The papers are in, the field is set, and it looks like Fairhaven has three real races in the April 4 election.

Four people are vying for one seat on the Selectboard, including incumbent Geoffrey Haworth. Bernard Roderick, who was up for re-election for his seat on the School Committee decided to forgo that race and opted to run for Selectboard instead. Daniel Freitas, a member of the Board of Public Works, and Pattie Pacella, who works as a temporary secretary in the planning office on the Community Development Block Grant, are also running for Selectboard.

The School Committee race, with two seats up for election, including the one vacated by Mr. Roderick, has three contenders. Incumbent Stasia Powers is running for re-election and two newcomers, Michael McNamara and Tatiana Andrade, also returned papers.

The Fairhaven Housing Authority will see three people vying for one, unexpired term that became vacant when Paul Days, who was elected last year, resigned.

Thomas Arsenault, who lives in one of the FHA properties, is running for the seat. John K. Farrell, Jr., who is a member of the Planning Board is also running for the seat. An old name in Fairhaven politics, Michelle Merolla, also resurfaced, with Mr. Merolla returning papers for the FHA.

Mr. Merolla is a former School Committee member, having served in the late 1990s and early 2000s. Ms. Andrade, who is running for School Committee, listed the same address as Mr. Merolla on filing papers.

The resignation of Kaisa Cripps from the Planning Board has resulted in an unexpired term on the ballot for that seat. Cathy Melanson, owner of Emma Jean's and EJs is the only one who will be on the ballot for that seat. Ms. Melanson has had public and prolonged clashes with the PB over various aspects of building and renovating for her two businesses, but mostly over parking.

Most of the fields are uncontested. Peter DeTerra will run unopposed for re-election to his seat on the Board of Health.

Jeffrey Lucas and Ann Richard will run for their seats on the Planning Board unopposed.

Town Clerk Eileen Lowney, Board of Public Works member Michael Ristuccia, and Commissioner of Trust Funds Barbara Acksen will all be unopposed on the ballot

Town Meeting members will also be voted in on April 4. According to town clerk Eileen Lowney, there will be a total 90 blank spots on the ballots throughout town for TM members. Each precinct votes for TM members separately.

Precinct 1 will have 7 blanks; Precinct 2 will have 17; Precinct 3 will have 27; Precincts 4, 5, & 6, will all have 13 blank spots on the ballot for TM members. •••



their way back to the truck to ensure there was no one left inside. Both detectives went underwater and attempted to look inside the truck. However, the visibility was zero due to the debris that was kicked up from the sea floor from the impact of the truck. Due to the frigid conditions, officers were prevented from remaining in the water for any considerable length of time. Sergeant Michael Botelho relieved the detectives and made an attempt to ensure there no additional occupants were trapped inside.

A commercial diver, properly equipped for cold water exposure was finally able to determine that no one was left inside the truck.

Steven Kimball said he was on scene when police pulled Mr. Cardin out of the vehicle, and he said he helped them get him to land.

"I couldn't believe it. I said 'I know that guy," said Mr. Kimball. "Those officers jumped right in the water. It's Fairhaven's finest. They went right in the water."

Big Wheels Towing used a crane to lift the truck out of the water and turn it right-side up. Then a tow truck took it away.

Diver Tommy Johnson scoured the bottom to remove personal items that fell out of the truck.

Officials from the Mass. Department of Environmental Protection were also on scene to assess possible pollution. They said that part of the cove would be posted for a few days so no one would quahog there until the tide could clear away any leakage from the truck.

The Fairhaven Board of Public Works removed a light pole that was snapped off from its base by the truck before launching into the bay. All exposed wires from the severed light pole were rendered safe by Fairhaven Electrical Inspector John Cottrill.

# Law students win against "trademark bully"

Suffolk University Law School students helped secure a victory for a small-business client whose use of the MonsterFishKeepers name was opposed by the Monster Beverage Corp.

The holding company for the Monster energy drink empire maintained that it owns the word "Monster," but the U.S. Trademark Trial and Appeal Board disagreed, dismissing the company's opposition to the name that businessman Li-Wei Chih of Silver Spring, Md., uses for his MonsterFishKeepers.com tropical aquarium website. Chih had sought to register the brand name for use on apparel.

Students from Suffolk Law's Intellectual Property & Entrepreneurship Clinic worked on the case for more than three years under the direction of former clinic director Eve Brown. Brown and Intellectual Property Clinic students also won a trademark case against Nautica in October 2015 on behalf of another small business, Nautigirl Brands, LLC. Brown refers to both Monster and Nautica as "trademark bullies."

Monster Energy's claims that it owns a "family" of trademarks all using the word "Monster" was struck down by the U.S. Trademark Trial and Appeal Board ruling.

"In defeating the world's Number One trademark bully;" the students are helping MonsterFishKeepers and hundreds of other small businesses faced with Monster Energy's "over-reaching argument that it owns the word 'Monster," said Brown.

"Monster Energy's claim that they are so famous that they should be able to exclude anyone else from using 'monster' was struck down," she said. "Monster Energy was deemed to be famous only for energy drinks, which will again negatively impact their ability to prevent others from using the word in other categories."

The board did rule that the MonsterFishKeepers logo, which featured an M with a devil's horns and tail, was too similar to the beverage company's logo.

Chih's MonsterFishKeepers forum featured a Feb 1 post saying: "I have been battling my MonsterFish-Keepers trademark with Monster Energy since 2012. As of today I can say I've beaten the monster! Monster Energy now has a ruling against its ludicrous and overreaching argument that it owns the word 'Monster.' Hope this ruling will help the hundreds of other small businesses being bullied by them."

The blog post then goes on to thank Brown and Suffolk University.

The Suffolk Law students involved in the case, some of whom have graduated, included: Carl Alexander Chiulli, '13; Jerome Daniel Duval, '13; Laura Lipinski, '14; Casey Parent, '14; Maria Jose Rivera, '15; Emmanuel Gonzalez, '15; Meaghen Kenney, '16 "The future holds promising collaborations between the Law School and its alumni in the battle for access to justice for small business," said Brown.

## **Triumphs spur new legal firm**

Their success in these cases has led to the formation of Bricolage Law, a legal services organization comprised of several intellectual property clinic graduates and their former professors: attorney Brown and entrepreneurship consultant Paul Nagy. The new firm will represent small, independent businesses of moderate means in intellectual property and business-law related matters.

"The goal is to fill the gap between clinic-eligible clients who cannot afford any legal fees and the highly profitable large corporations that can afford biglaw," said Brown.

"There is, unfortunately, a massive population of small-business owners in the middle who don't qualify for pro bono help but need sophisticated, experienced legal assistance to keep them afloat," said Brown, who currently directs an Entrepreneurship & Intellectual Property Clinic at Boston University School of Law. "Clinic alumni are uniquely and perfectly situated to offer this help, since they have all been specially trained in providing this type of counsel, have a deep understanding of both law and business."
