#### Feds set up election day hotline

From press release materials

United States Attorney Emily Gray Rice announced the establishment of an Election Day hotline in coordination with the U.S. Justice Department's nationwide Election Day program for the general election on November 8, 2016. The hotline number is (603) 230-2503.

The Department of Justice has an important role in deterring election fraud and discrimination at the polls, and combating these violations whenever and wherever they occur. The Department's long-standing Election Day Program furthers these goals, and also seeks to ensure public confidence in the integrity of the election process by providing local of contact within Department for the public to report possible election fraud and voting rights violations while the polls are open on Election Day.

Federal law protects against such crimes as intimidating or bribing voters, buying and selling votes, altering vote tallies, stuffing ballot boxes, and marking ballots for voters against their wishes or without their

input. It also contains special protections for the rights of voters and provides that they can vote free from acts that intimidate or harass them. For example, actions of persons designed to interrupt or intimidate voters at polling places by questioning or challenging them, or by photographing or videotaping them, under the pretext that these are actions to uncover illegal voting may violate federal voting rights law. Further, federal law protects the right of voters to mark their own ballot or to be assisted by a person of their choice.

The franchise is the cornerstone of our American democracy. We all must ensure that those who are entitled to the franchise exercise it if they choose, and that those who seek to corrupt it are brought to justice. In order to respond to complaints of election fraud or voting rights abuses regarding the November 8, 2016 general election, and to ensure that such complaints are directed to the appropriate authorities, **AUSA** Zuckerman will be on duty in this District while the polls are open. He can be reached at 603-230-2503.

In addition, the FBI will have Special Agents available in each Field Office and Resident Agency throughout the country to receive allegations of election fraud and other election abuses on Election Day. The FBI can be reached by the public at 603- 472-2224.

#### Fairhaven to hold Veterans Day parade and flag raising

Fairhaven will hold its 11th annual Veterans Day parade on Friday, 11/11, at 9 a.m.

Groups will form at Livesey Park in North Fairhaven. Veterans are asked to meet by 8:30. Parade will step off at 9 a.m. sharp.

The parade will travel along Main Street from Benoit Square in North Fairhaven, south to Fairhaven High School. A brief ceremony will include the raising of the impressive 30x50 foot flag.


Veterans who cannot march should go to the Senior/Recreation Center by 7:45 a.m., where transportation will be provided. Coffee and donuts for all veterans at the Senior Center until the vans leave for the parade. The Lions Club will provide free coffee and donuts at the North Fairhaven Improvement Association building in Benoit Square at 8 a.m.

Spectators are asked to line the route and go to the High School to show their support. Homeowners along the route are asked to display the US Flag. Organizers hope to keep Veterans Day as a time to remember the sacrifices that men and women in uniform have made in keeping this

country safe and secure.

You can show your support for veterans by attending this event. Activities should end by 11 a.m.

After his retirement, he refinished his 1953 Chevrolet and won many best of shows and first place trophies with it. He also joined the North Fairhaven Improvement Association. The first North Fairhaven Classic Auto Show was started by him and his friends from the Association. It ran successfully for many years. When it was time to restore the North Fire House, Fairhaven volunteered his help as much as he could. Ernie really enjoyed working there. He also enjoyed taking part in the Halloween Parade and the Easter Egg Hunt.

Ernie was married to his wife, Beverly, for sixty years. They had five sons, of whom he was so proud.

#### **Shellfish Reopened**

The Division of Marine Fisheries has reopened waters south of Cape Cod to shellfish harvesting, including Buzzards Bay. Due to the dissipation of a potentially toxic phytoplankton bloom of Pseudo-Nitzshia and the results of toxicity testing, DMF has concluded that shellfish in the reopened areas are safe to harvest for human consumption.

DMF issued a shellfish harvest closure in Buzzards Bay, Mount Hope Bay and Lackeys Bay on October 7, 2016 and issued a closure in all waters south of Cape Cod on October 9, 2016. Shellfish closure notices can be found on the DMF website: www.mass.gov/eea/agencies/dfg/dmf/

#### Fairhaven Police officers recognized

Seven Fairhaven police officers were presented with the Massachusetts Police Association's Life Saving Awards on Thursday, 10/27, for their actions earlier this year.

On February 17, Fairhaven Police and Fire Departments responded to Goulart Memorial Drive after reports of a vehicle in the water. They found a Ford pickup truck upside down in approximately seven feet of water, 15 feet from the shore. Officer Scott Coelho waded out to the vehicle and determined there was someone still inside. Officers Kevin Chasse and Alexander Kisla rushed into the frigid water to help.

Officers Coelho and Kisla managed to free the operator from the vehicle after cutting his seatbelt, while Officer Chasse swam around to the passenger side to determine if there was anyone else trapped inside.

Resident Nathan Picard jumped in the water and helped the officers bring the operator to the road. Fairhaven Fire Department Deputy Chief Todd Correia also entered the water and helped lift the victim back to dry land.

As the first round of officers were exiting the 39 degree water, Detectives Jerald Bettencourt and Scott Gordon jumped in to ensure there was no one left inside. Both detectives went underwater and attempted to look inside the truck, but visibility was zero. Due to the frigid conditions, officers were prevented from remaining in the water for any considerable length of time. Sergeant Michael Botelho relieved the detectives and made an attempt to ensure there were no additional occupants trapped inside.

A commercial diver, properly equipped for cold water exposure, was finally able to determine that no one was inside.

The driver, David Cardin of West Island, was transported to St. Luke's Hospital in critical condition. He has since been released from the hospital and is living at home.

#### Acushnet TM facing 20+ articles; Selectboard rejects land deal

Acushnet voters will face 26 articles at the special town meeting on November 14. Spending articles total approximately \$484,000 and include funds to buy several vehicles, a piece of property for open space purposes, and funds for the continuing renovation of the Parting Ways Building.

At their meeting on October 24, Selectboard members rejected a request by the Buzzards Bay Coalition and supported by the Community Preservation Committee, to hand over \$150,000 in CPC funds to buy a nine-acre property that would be owned by the BBC, not the town. The property abuts White's Farm, and is known as the Milos/Jaros property.

Allen Decker of the BBC told the board that the organization will spend \$210,000 for the property. The \$150,000 would be supplemented by grant money and other funds. The \$210,00 includes \$15,000 for demolition of buildings on the property, \$25,000 for site restoration by the BBC, and \$10,000 in closing costs. The BBC would get a \$35,000 municipal mini grant and private funds for the remaining costs.

When Mr. Decker addressed the board on 10/24, he noted that the wording on the draft town warrant was not correct, that it was the opposite of what the BBC had agreed to. He said the BBC was looking to be the owners of the property and that it would be open to the public.

He said the town would own the Conservation Restriction (CR).

Interim Town Administrator Kevin **Paicos** acknowledged that changed the wording on the article because he believed it was illegal for the town to give public funds to a private organization to buy property that would then be owned by the private organization, not the town. He said the town should own the property outright in order for it to be truly protected in perpetuity. He said the Conservation Commission or another entity could hold the CR to for additional protection.

Selectboard member Kevin Gaspar agreed. He asked why the town would pony up \$150,000 not to own the property, when they could own it outright for an additional \$60,000.

He said it was "very concerning" and he would not support it until he was convinced it was in the best interest of Acushnet residents.

According to their website, the BBC owns two properties in Acushnet, the 19-acre Sawmill and the 50-acre LaPalme Farm. The organization has protected 7,500 acres from development. In addition to the two Acushnet properties, it also owns The Bogs and Tripps Mill, both in Mattapoisett; and Horseshoe Mill in Wareham. The size of those properties is not clear on the BBC website.

Mr. Decker seemed a bit taken aback at the resistance to the article, saving the BBC has used the formula for other properties and was sure it was not only legal, but would provide more public access, not less.

"We have done this strategy successfully in other communities, said Mr. Decker.

Board members, Mr. Decker, and Mr. Paicos bandied about a bit the details of public access, liability, cost of the demolition, and the future prospects of a sale, should the BBC decide to dissolve, convert its assets to a for-profit model, or sell to a forprofit company.

Mr. Paicos maintained that using the Chapter 40 model of outright ownership by the town was the best way to protect the interests of Acushnet residents.

"I would never, ever, ever give taxpayer money to a private entity," for them to buy property for themselves, said Mr. Paicos.

Mr. Decker argued that the town would own the CR.

"I would still say it's a bad idea," said Mr. Paicos, adding later in the conversation that a CR "is not nearly as strong as Chapter 40 protection and a conservation restriction.'

He said the town should buy the property under the provisions of Chapter 40 and assign the CR to the BBC.

"To me, that's the gold standard," said Mr. Paicos.

When the talk turned to the stellar reputation of the BBC, Mr. Paicos said that was not the issue.


"I'm talking more a matter of public policy," he said.

In the end, the board agreed with Mr. Paicos and voted to change the wording on the article. The final wording, however, allows for town meeting to vote either way. A provision in Article 20, states, "or in the alternative to grant and assign such funds to the Buzzards Bay Coalition to provide for its purchase, rehabilitation and restoration of the property.'

Voters at TM will be able to choose whether or not the town will buy the property outright, give the money to the BBC to buy it for itself, or simply not appropriate the funds at all.

In another land article, the board voted to support a request by

Freetown to acquire a piece of property on the town line. Freetown wants to build senior housing on the property, which has been contaminated by the company that owns it.

The town of Acushnet owns a small portion of the property, taken by tax title.

The deal is contingent on the town of Freetown acquiring the funds to clean up the hazardous site.

The aforementioned vehicle articles include: \$68,085 (article 15) for a police cruiser; \$40,000 (article 23) for a truck for the Highway Department; and \$51,800 for a truck for the Water Department. The Council on Aging is also asking for \$2,500 to repair a retired police department SUV. The Selectboard voted to support all those requests.

Town meeting will also be asked to make a decision on some bylaws changes.

Article 12 would add a provision to the bylaw governing the Business Village District requiring all buildable lots to connect to municipal sewer and water.

Article 13 would change the set-

backs at the gravel pit on South Main Street, in the industrial zone.

Article 14 would make changes to the bylaw that governs abandoned vehicles on private property.

Building Inspector James Marot told the board that his hands are tied in some instances when he is trying to get properties cleaned up of old vehicles. The amendments include changing the words "car" and "automobile" to "motor vehicle," or just "vehicle."

Mr. Marot said he has been arguing with residents over the vehicles, and they are maintaining that the old cars are "antique automobiles," which are excepted under the bylaw.

"It is not," said Mr. Marot, "It's a piece of junk."

He said the new wording will improve his standing in court proceedings.

The board also voted to support Article 25, which would change the town charter to eliminate the residency requirement for the Town Administrator. A town charter change has to be approved by the state legislature. •••

## 3-year-old killed in Acushnet accident

Three-year-old Victoria Varieur was killed when a car her father was working on apparently rolled onto her on Tuesday morning, according to statements from the Bristol County District Attorney's Office and the Acushnet Police Department.

Acushnet Police received the 911 call at 11:43 a.m. The child was pronounced dead at the scene her father was transported to St. Luke's Hospital.

A preliminary investigation indicates that the girl's father was repairing his Ford Excursion in the driveway of the home at 13 Jean Street when the vehicle rolled down the driveway and struck Victoria.

The vehicle continued down the driveway and came to rest against another vehicle parked on the opposite side of Jean Street.

"At this time no foul play is suspected," reads a statement by the DA's office.

The investigation is ongoing and is being conducted by the Acushnet Police and Mass. State Police Detectives assigned to the DA's office.






