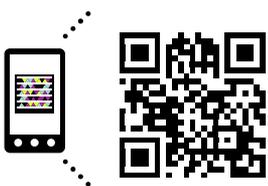

Fairhaven resident wins \$10+ million on ticket from Fhvn 7-11

Mass. State Lottery Press Release

Stephen Pereira of Fairhaven is the winner of a \$10.04 million jackpot prize that was at stake in the Massachusetts State Lottery's Megabucks Doubler drawing that took place Saturday, March 20, 2021.

After having first pulled into a gas station that was closed, Pereira proceeded to 7-Eleven, located at 188 Huttleston Ave. in Fairhaven, to purchase his ticket. The combination of 2-16-23-27-31-45 on his Quic Pic ticket matched the six numbers selected in Saturday's drawing, resulting in his jackpot win.

The \$10.04 million jackpot is the largest won in the Megabucks Doubler game since March 11, 2017, when an \$11.34 million jackpot was won on a single ticket sold in Clinton.

Prior to visiting the Mass Lottery's headquarters in Dorchester to claim his prize, Pereira was able to verify that he indeed won the jackpot by using the Mass Lottery app on his smartphone to scan the code on his ticket. When he did so, a message stating the amount of his prize appeared and virtual confetti rained

down the screen accompanied by the sound of trumpets.

Pereira chose the cash option on his prize and received a one-time payment of \$8,424,485 (before taxes). Pereira plans on paying off his mortgage and helping out his

children with his winnings.

The store will receive a \$25,000 bonus for its sale of the jackpot winning ticket.

Megabucks Doubler drawings take place every Wednesday and Saturday evening. Tickets are \$1.

Collasius unseats Knowles in Fairhaven

Fairhaven voters have spoken, choosing two newbies to politics and returning three incumbents, in the four contested races. Unofficial numbers show that about 19% of the electorate voted on Monday, 4/5/21, to choose officials on all boards and committees, and town moderator.

According to the Town Clerk, Fairhaven has 11,920 registered voters, and a total of 2,272 participated on Monday for a voter turnout of about 19%.

In the upset of the night, newcomer Don Carlos Collasius beat incumbent G. Bourne Knowles IV, in a close, but safe 1066 to 1030 count, for Tree Warden.

The Selectboard race also saw incumbent Bob Espindola fighting to keep his seat against challenger Lisa Plante, with Mr. Espindola retaining his seat 1766-491.

School Committee also saw a contested race, with three people running for two seats. Incumbents Donna McKenna and Colin Veitch both retained their seats with 1284

and 1282 respectively. Challenger Cathleen Marchessault made an impressive showing in her first foray into Fairhaven politics, getting 937 votes.

Board of Health also had a contested race, with two vying for one open seat. Newcomer Kevin Gallagher pulled off an impressive win over Barbara Acksen, who was on the BOH from 2012-2015. Mr. Gallagher received 1602 votes to Dr. Acksen's 558.

Other races, all uncontested, were: Board of Public Works with incumbents Robert "Hoppy" Hobson and Marcus Ferro re-elected with 1171 and 1249 respectively; Planning Board with incumbents Cathy Jean Melanson and David Braga re-elected with 1073 and 1260 respectively; an unexpired term for Planning Board held by Jessica Fidalgo who was elected with 1378 votes; Housing Authority, with Ronnie Manzone winning a full term, with 1500 votes, to the seat she had been appointed to, and Marc Scanlon elected to fill the unexpired term he was appointed

Pickleball Construction

Representative Bill Straus (D-Mattapoisett) announced that the Mass. Department of Conservation and Recreation (DCR) Commissioner Jim Montgomery has notified him that construction of the six pickleball courts at Fort Phoenix State Park will occur this summer. The construction is slated to begin in early June, 2021 with a completion date in October 2021.

"Pickleball has become a popular outdoor court game that people of all ages will enjoy at one of most popular state parks in the Southcoast region. I commend DCR Commissioner Montgomery and the Baker Administration for responding to the local request of residents and guaranteeing funds to get this project to be a reality," said Rep. Straus.

Recently, Fort Phoenix has seen improvements to the tennis courts with new paving, striping, new tennis nets and the addition of the pickleball courts will offer the residents of the Southcoast another venue to be outside and enjoy the amenities that our state park has to offer. The pickleball project for Fort Phoenix has a budget of \$300,000 through the state agency.



Recipe of the Week

Sheet Pan Chicken & Veggies

- 1 pound Brussels sprouts, trimmed and cut in half
- 2 large sweet potatoes, cut into wedges
- 1 medium sweet onion, cut into wedges
- 2 tablespoons olive oil, divided
- 1 1/4 teaspoons kosher salt, divided
- 3/4 teaspoon ground black pepper, divided
- 4 (5 ounce) bone-in, skin-on chicken pieces

Mustard Vinaigrette:

- 2 tablespoons grainy mustard
- 4 teaspoons champagne vinegar
- 1 tablespoon maple syrup
- 1/2 teaspoon kosher salt
- 1/4 teaspoon cayenne pepper

Preheat the oven to 425°. Line a rimmed baking sheet with foil.

Prepare chicken and veggies: Toss Brussels sprouts, sweet potatoes, and onion on the prepared pan with 1 tbsp oil, 1 tsp salt, and 1/2 tsp pepper; spread into a single layer.

Sprinkle chicken with remaining 1/4 tsp salt and 1/4 tsp pepper and nestle it, skin-side up, in between the veggies on the baking sheet. Brush remaining oil on skin.

Roast in preheated oven 45 mins or until chicken is cooked through, golden and crisp. An instant-read thermometer inserted near the bone should read 165°.

While the sheet pan dinner is cooking, prepare vinaigrette. Whisk mustard, vinegar, maple syrup, salt, and cayenne together in a small bowl until well combined.

Drizzle sauce over veggies and chicken.

to fill, with 1406; Town Moderator, with incumbent Mark Sylvia re-elected with 1596 votes.

Planning Board also had a seat to fill an unexpired term previously held by Wayne Hayward. Mr. Hayward launched a write-in campaign to get his seat back. According to the tally sheet there were 138 write-ins, but they had not been tallied by press time.

Also on the ballot was Commissioner of Trust Funds, with one open seat and no one on the ballot. According to the clerk's unofficial tally sheet, there were 65 write-ins, but they had not been counted by press time.

In a decades long tradition, after the election, Town Clerk Carolyn Hurley announced the unofficial results in the banquet room at town hall, which was televised on Channel 18, livestreamed, and available via Zoom. Selectboard Chairperson Daniel Freitas and board member Keith Silvia were joined by Maria J. Carvalho of the Cable Advisory Board to play a bit of Fairhaven trivia while they waited for the results. Candidates were invited to address voters.

In the chit-chat before the results were announced, Mr. Freitas said it was a good turnout probably because it was a beautiful day, a nice day to hold signs.

Mr. Freitas said all candidates were

"Because I'm committed to the next three years to serve everyone in the community as best as I possibly can," said Mr. Espindola.



More budget talk from the Acushnet Selectboard

The Acushnet Selectboard approved some Fiscal Year 2022 budgets, including Fire and Police, after brief presentations during a 3/30 morning meeting (see 4/1/21 issue).

Conservation Agent Merilee Kelly presented her \$87,648 FY22 budget reflecting a \$12,000 increase in funding for the Town's contract with a stormwater collaborative.

During Ms. Kelly's presentation, however, Mr. Gaspar asked whether the stormwater "MS4 permit" budget should be removed from the Conservation Department budget and placed within the Planning Board's budget since the Planning Board is the authority concerned with stormwater.

Ms. Kelly said that might make more sense, and the board made it part of its motion when approving the conservation budget.

Mr. Gaspar commented that he would like to see the process move forward with establishing a stormwater permit fee schedule and

advocated for funding the stormwater agent salary through fee revenue instead of the tax levy.

In other business, the board voted to waive its Right of First Refusal under Chapter 61A for a portion of 540R Main Street. That property is slated for lease to a solar farm developer.

The board approved \$8,950 in federal CARES Act funding for the Acushnet Emergency Management Agency to buy a trailer to store and transport COVID-19 testing related equipment.

The board approved an additional \$2,500 to supplement last year's Town Meeting-approved funding for the park commissioner's pavilion project planned behind the Veterans' Memorial.

The footprint of the pavilion is being expanded to account for social distancing measures.

The board also approved a Reserve Fund Transfer of \$405 for the Planning Board's advertisement line item, which has dipped into the red. Ms. Gaspar recommended approving

the fund transfer but wanted Town Administrator Julie Hebert to look into whether the applicants or the Town should be paying the advertising fees.

The board also approved a Class II license for Rep Weld Corp.

Chair has abandoned Selectboard

For the past 32 years we have enjoyed and celebrated our "sister


